

**2017 MPF TRAVEL VOUCHER COMPETITION
TERMS AND CONDITIONS**

1. Information on how to enter the 2017 MPF Travel Voucher Competition (the Promotion) and prize details form part of these Terms and Conditions. If there is any conflict between these Terms and Conditions and any other published material, these Terms and Conditions will prevail.
2. The Promoter is Macquarie Premium Funding Pty Limited ABN 82 127 517 677, 1 Shelley St Sydney NSW 2000 (The Promoter or We). Telephone 02 8232 3333. The Promotion opens at 10am AEST 28 February 2017 and the Promotion closes at 5pm AEST Wednesday 31st May 2017 (Promotional Period).
3. Entry is open to Australian and New Zealand residents who are over the age of 14 and are users of the Promoter's Edge platform for obtaining insurance quotes as set out in clause 7 below (Eligible Entrant).
4. Directors, employees and associated companies of the Promoter are ineligible to enter.
5. Eligible Entrants who participate in the Promotion are deemed to accept these Terms and Conditions, including the Privacy Statement which describes the handling of their personal information, including direct marketing. Eligible Entrants can change their marketing preferences by telephoning us on 1800 806 310 or visiting www.macquarie.com.au/optout-bfs.
6. Eligible Entrants may enter as many times as they wish with a new quote for each new entry.
7. Eligible Entrants are eligible for entry into the Promotion if, during the Promotional Period:
 - they refer a client to the Promoter via the Eligible Entrant's software interface with the Promoter or by creating a quote in Edge at <https://www.macquariepacific.com/edgev2/#/login>;
 - as a result of that quote, that new client is approved for a loan from the Promoter; and
 - that client has not been approved for a loan from the Promoter for the past 12 months.
8. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants (including an Eligible Entrant's identity, age, email address and place of residence) and to disqualify any Eligible Entrant who tampers with the entry process or provides incorrect or invalid details, and to reject any entry that is not in accordance with these Terms and Conditions. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
9. There is a chance to win (1) prize for the broking firm of the winner. The prize is a travel voucher valued at AUD \$5000.00, redeemable with the Prizing Agency (33 Degrees Worldwide Pty Ltd) to be used for hotel, car hire, car transfers, flights, conference facility hire and/or dining only (Travel Voucher).
10. The winner may only select guests over 18 years of age to redeem the prize. The winner must nominate one person to act as the point of contact with 33 Degrees for all arrangements.

11. The Travel Voucher must be used in one booking transaction for one event / trip. The Travel Voucher cannot be used for Airbnb or hotels that are less than 4 star. The Travel Voucher must be used within 12 months or will be forfeited.
12. The Winner will be required to sign a prize acceptance form including liability and publicity waiver within 6 weeks of being notified as the winner to formally accept the prize.
13. All guests who use the Travel Voucher will be required to sign a prize acceptance form including liability and publicity waiver before the prize booking can be made. Winner must finalise the details for the use of their Travel Voucher within 12 weeks of the prize draw and all travel must be completed within 12 months of the prize draw. Winner must book at least 60 days prior to intended travel departure.
14. Availability cannot be guaranteed during Christmas, School holiday and special event periods. All passengers must travel together on the same flights and stay at the same property.
15. No compensation or alternative travel plans will be arranged should the winner and/ or their guest miss their outbound or return flights or fail to meet any check in requirements for any reason. These costs will be the responsibility and expense of the winner and travel partner. A credit card imprint may be required from the winner at check-in to the hotel for all incidental charges.
16. Once booking is confirmed no changes are allowed, unless otherwise authorised by the Promoter in its absolute discretion and if permitted will incur a fee of \$150 including GST plus supplier charges which is payable by the winner.
17. Comprehensive travel insurance is highly recommended and at the expense of the winner. If the winner chooses not to purchase travel insurance they will be required to complete a travel insurance waiver form acknowledging that they understand the benefits of travel insurance but decline to take out a policy.
18. In the event that an element of the prize is cancelled or postponed for any reason, the winner forfeits the specified element and no cash alternative offer will be granted in lieu of the part of the prize.
19. Unless expressly stated in these terms and conditions all other expenses outside of the Travel Voucher become the responsibility of the major prize winner and their companion including but not limited to all meals, spending money, incidentals, mini-bar, laundry, room service, telephone calls and all other ancillary costs.
20. The winners agree they will not sell or otherwise provide their story and/or photographs to any media or other organisation.
21. If car hire is selected as part of the Travel Voucher rental conditions apply including but not limited to minimum driver age 21 and maximum driver age 85, the nominated driver must have held a full licence for at least 1 year). If the winner doesn't meet the criteria (eg. suspended licence) they must nominate a guest who meets the car rental company's requirements and they must be the nominated driver on the rental agreement)
22. If the Winner elects to use the Travel Voucher to enter a country that requires a Visa, the winner and their guest(s) must meet the eligibility requirements and will be responsible for securing the requisite entry Visa, prior to their trip.

23. Prizes, or any unused portion of a prize, are not exchangeable, transferable or redeemable for cash unless stipulated otherwise.
24. Prizes are subject to the standard terms and conditions of individual prize and service providers.
25. If any prize (or part of any prize) is unavailable, the Promoter, in its discretion, reserves the right to substitute that prize (or that part of the prize) with a prize to the equal value and/or specification, subject to any written directions from a regulatory authority.
26. The prize draw will take place at 10am AEST on 1 June 2017 at 1 Shelley Street, Sydney and will be conducted by the Promoter. One (1) winner will be drawn at random who meet the eligibility requirements as set out above in clause 7.
27. The Promoter reserves the right to draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be announced on 2 June 2017 on the Promoter's LinkedIn account, followed by a congratulatory email to the winner. The Promoter's decision is final and no correspondence will be entered into. The prize will be delivered within 28 days of the prize draw.
28. Subject to the unclaimed prize draw clause, if for any reason a winner does not take a prize or an element of a prize at the time stipulated by the Promoter, then the prize or that element of the prize will be forfeited.
29. The Promoter reserves the right to redraw in the event of a prize-winner being unable to satisfy these Terms and Conditions, or forfeiting through ineligibility or otherwise. If a prize remains unclaimed or is forfeited through ineligibility or otherwise, the Promoter will conduct an unclaimed prize draw in order to award a prize on 10am AEST on 1 July 2017 at 1 Shelley Street, Sydney, New South Wales, Australia, subject to directions from a regulatory authority. In the case of a winner, they will be notified by congratulatory email or by phone or letter.
30. If this promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law (a) to disqualify any Eligible Entrant; or (b) subject to any written directions from a regulatory authority, to modify, suspend, terminate or cancel the Promotion, as appropriate.
31. Except for any liability that cannot be excluded by law, the Promoter (including their respective officers, employees and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion, including, but not limited to, where arising out of the following: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or Eligible Entrant ; or (f) use of the prize.
32. Eligible Entrants consent to the Promoter using their name, likeness, image and/or voice in the event they are a winner (including photograph, film and/or recording of the same) in any media for an unlimited period without remuneration for the purpose

of promoting this Promotion (including any outcome), and promoting any products manufactured, distributed and/or supplied by the Promoter.

The Promoter collects personal information in order to conduct the Promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. All entries become the property of the Promoter.
